With the dissemination of the "more economic" approach in all areas of EU competition law, costs have become a key concept in antitrust proceedings. But to most lawyers and in-house counsels, the very notion(s) of costs remains cryptic.

The purpose of this half-day compliance seminar is thus to offer a complete overview of costs in EU competition law. To this end, it starts by providing some definitions of costs, and then reviews the use of costs in the context of (i) the proof; (ii) the justification; and (iii) the sanction/compensation of infringements.
